

A delegate holds one vote for each NWSEO member in the branch represented. The "At a Glance" table below displays each delegate's status relative to the Delegate Incentive Program requirements (25% of the 2019 certified delegate total and at least two Branches for Regions that have more than one Branch) for reimbursement of approved travel expenses for attendance at the 2020 NWSEO Convention.

The "By Branch" table below displays the current number of votes for each Branch along with the Delegate and Alternate Delegate. These reports are being posted regularly to resolve any discrepancies before the final numbers are certified at the Convention.

The number of votes listed for each delegate will be reduced if any non-delegate members from the Branches that delegate represents attends the Convention (as those non-delegates are still entitled to cast their own vote). These preliminary results will be adjusted at the Convention based on the actual attendance. 
