

## NWSEO Pressured the NWS to End the Hiring Freeze Now We Need Your Help: Recruitment Rebate Extended

(March 6, 2014) NWSEO knows how crippling the hiring freeze was to NOAA and the NWS, and no one was more vocal about this issue than NWSEO. NWSEO pressured the agency to put an end to these dangerous and unnecessary vacancies. In the weeks and months to come, the NWS will be filling critical positions in operational units due largely to the diligent efforts of our professional organization. NWSEO is now focusing efforts to keep the NWS fully funded in 2015.

## **Recruitment Rebate Extended**

The January Hiring Freeze Arbitration was one of the longest and most critical arbitrations in NWSEO history. It was also one of the most costly. If we are successful in this arbitration, the NWS bears the responsibility to keep most positions in WFOs filled. NWSEO is now gearing up for another campaign to keep the NWS fully funded in 2015. Our organization is in need of new membership and we are working on a recruitment drive to provide the strength we need to continue our important mission. Only through solidarity of the workforce and the financial support that it brings will NWSEO be able to protect your paycheck.

As members, we need your help. With an increasing number of retirements and movement into management positions due to the lifting of the hiring freeze, NWSEO needs new members <u>now</u>. Because of this, the \$100 dues rebate for any new member who joins by 1187 form is extended to October 1, 2014.
